the strategy to incorporate some priority actions which include:

- 1. A process of auditing and strengthening services' mechanisms of consumer and community engagement; and
- 2. Building capacity in consumers accessing or potentially accessing sexual health services in order to help shape those services at a systemic level.

Our organisation Health Consumers Queensland would be very happy as an organisation to assist with both of these actions.

What do you like most about the Strategy? The Strategy contains two issues our organisation (Health Consumers Queensland) has been hearing about from members of our network:

- 1. The need for increased access statewide to services for transgender/gender questioning children (priority action 6.5). Families report:
- * finding it hard to get referrals to appropriate services
- * a long wait list for services at the LCCH Gender Clinic (12 months+ to meet with the psychiatrist, another 6 months wait to meet with the endocrinologist and then another 6 month wait list to go back to psychiatrist before they can start treatment).
- * a gap in services for the 15-17 age group, with a focusing on pre-pubescent children. This has far reaching implications for the mental health of those 15-17 year olds.
- * the need for several regional public clinics, to meet the needs of children outside SEQ who can't easily travel/
- * the need to change Commonwealth law around cross-sex hormone therapy (Stage Two treatment) so that their children don't have to go through the Family Court for this treatment
- 2. The need for routine implementation across HHSs of the Maternity and Neonatal Clinical Guideline re access to the rapeutic termination (6.7) we are separately putting in a detailed submission to the Abortion Law Reform Inquiry on these issues.
